## TREADING LIGHTLY ON THE EARTH

Sri Lankan vegetarian food - Katie de Kauwe.

Sri Lanka offers one of the oldest and most sophisticated vegetarian cuisines in the world. The incredible variety of plant produce, from aubergine (vambatu) to cashews (caju), from lentils (parippu) to Jack fruit (polos), from green beans (bonchi) to bitter gourd (karawila), from coconut pol) to kale (kaela), Ala (potato) combined with strong and ancient traditions of non-violence towards fellow animals from both the Sinhala and Tamil cultures (respectively, through Buddhism and Hinduism) has resulted in complex and refined vegetarian cooking. In partaking in this cuisine, we are enjoying delicious food, and we are also to quote the late International Court of Justice Vice President C G Weeramantry “treading lightly on the Earth”, by consuming produce with a far lower carbon impact than that of meat.

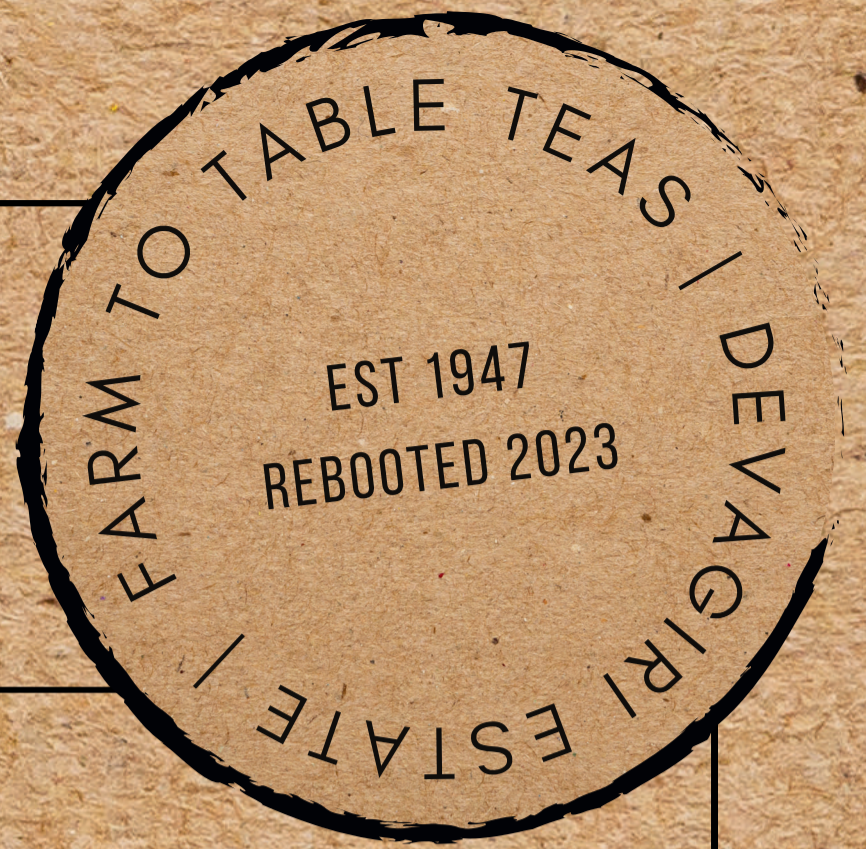
